

AIDS 2024 Pre-Conference Meeting: Addressing the Needs of International Migrants in Russia Amidst New Emerging Walls

Location: Campus CNRS, Villejuif, France (Zoom available)


This pre-conference meeting (on the eve of the AIDS 2024 international Conference), organized by Laboratoire Cermes3 and the Regional Expert Group on Migration and Health, aims to address the challenges faced by international migrants in Russia, especially in light of increasing socio-political barriers.

Key objectives:

- exploring the operation of independent civil society organizations within Russia's current social environment,
- understanding how migrants navigate their precarious circumstances to meet health needs amidst stringent migration policies and identifying survival strategies for the most vulnerable groups such as undocumented migrants, unrecognized refugees, people living with HIV, young females from Central Asia, and sexual minorities.
- The discussion will also cover the role of transnational civil society cooperation in supporting migrants across Eastern Europe and Central Asia.

The meeting will feature civil-society-based researchers and practitioners such as Zinaida Abrosimova from the Regional Expert Group on Migration and Health, as well as Kirill Barskiy, and Dmitry Korenev from the Shagi foundation. In the discussion part we aim to outline working strategies of support to the civil society in Eastern Europe and Central Asia.

The working language is English. Interventions in Russian and French will be translated into English.

Ce séminaire pré-conférence (à la veille de la conférence internationale SIDA 2024), organisé par le Laboratoire Cermes3 et le Groupe d'experts régional sur la migration et la santé, vise à aborder les défis auxquels sont confrontés les migrants internationaux en Russie, notamment à la lumière des barrières sociopolitiques croissantes.

Les objectifs du séminaire sont centrés autour :

- La discussion du fonctionnement des organisations indépendantes de la société civile dans un environnement hostile.
- La compréhension de la manière dont les migrants naviguent dans leurs circonstances précaires pour répondre à leurs besoins de santé face à des politiques migratoires strictes.
- L'identification de stratégies de survie pour les groupes les plus vulnérables tels que les migrants sans papiers, les réfugiés non reconnus, les personnes vivant avec le VIH, les jeunes femmes d'Asie centrale et les minorités sexuelles.

La discussion couvrira également :

- Le rôle de la coopération transnationale de la société civile dans le soutien aux migrants à travers l'Europe de l'Est et l'Asie centrale.

Le séminaire réunira des chercheurs et des praticiens de la société civile tels que :

- Zinaida Abrosimova du Groupe d'experts régional sur la migration et la santé.
- Kirill Barskiy et Dmitry Korenev de la fondation Shagi.

Lors de la discussion, nous viserons à définir des stratégies de soutien à la société civile en Europe de l'Est et en Asie centrale. Le séminaire se déroulera en anglais.
